W/S: Been a busy month with lots of rain. They are busy inspecting places for I&I issues, but when they are asking the property owners to make necessary changes, they are not following through. These issues are typically sump pumps not hooked up correctly, drain tiles and roof drains. Really struggling to get the residents to cooperate with the necessary changes. Mike Stoffel did mention that their efforts with the rainwater has made a noticeable difference. Other than that, plant is running good and Jason is working out great.
