- 5. Fire Presentation: Pisca years of service. Mayor Peterson and Fire Chief David Lontcoski made a small presentation to present former Fire Chief (and Mayor) Jim Pisca with a commemorative axe as a token of appreciation for his 49 years at the fire department and his dedication to the City. After the presentation there will be a small celebration at the Phillips Fire Station.
- 6. Discussion/Action regarding Billboard/Marketing Price County: Lynn Ludwig
 Lynn Ludwig presented the Council with an idea for renting billboards to market Price County
 for people to see on Hwy 51. The goal is to get people to put Price County on their radar as a
 place to come live and then also market visiting here to recreate. The Schools think it is a good
 idea and are on board. She still needs to do some discussing with the other entities to get final
 approval. The total she is looking for the City to contribute is roughly \$3,600-\$4,000.

Klimowski/ Heitkemper moved to recommend to the Common Council to support the billboards marketing Price County on Hwy 51 and contribute up to \$4,000. Roll Call: Clark – aye, Heitkemper – aye, Tomaszewski – aye, Stephan – aye, Elliott – aye, Klimowski – aye. Motion Carried

7. Discussion/Action regarding matching funds request for a playground equipment grant Lynn Ludwig Lynn than progressed to Phase 2 of the marketing Price County plan. She discussed having interest in applying for a grant that was a 50-50 match to put a piece of playground equipment in Bostrom Park to better market Phillips as people are driving through. It would require a \$40,000 commitment to match from the City of Phillips. Mayor and Clerk discussed how this year in the budget, there really is no place to pull the funding from. No further action was taken.

8. DPW and Water/Sewer Updates:

DPW: Jeff Williams thanked Lynn Ludwig for all her work and vision for down at the Skating Rink with the painting of the warming house. Rink is now closed for the season but will be double the size next year. Snow blower has been broken down for about 3 weeks now.

W/S: Made it through the negative 40 temps only had a few main breaks and freeze ups. Plant is running good otherwise, and Toelle has been working with Greg from Town & Country finalizing plans for the upgrade.

- 9. Wastewater Treatment Plant Upgrade Update:
 - a. Bid Acceptance for Phase 1 of Wastewater Treatment Plant Upgrade Bids were opened last Wednesday. 2 bids received. 1 was from Staab Construction in the amount of \$1,943,000 and the other was from August Winter & Sons in the amount of \$2,055,000. There are some additive bid items both companies gave quotes on to add to the project to get near our 2.1-million-dollar budget the City had set.

Clark/Elliott moved to recommend to the Common Council to accept the bid from Staab Construction in the amount of \$1,943,000 and the additive bid items 1,2,4 & 5 contingent upon approval of the DNR's Clean Water Loan funding. Carried.
