Mayor Peterson called the meeting of the Committee of the Whole to order at 5:26p.m. Members Present: Charles Peterson, Jerry Clark, Laura Tomaszewski, Marty Stephan, Bill Elliott, John Klimowski, and Bryce Schoenborn, and Autumn Gedde

- Clark/ Tomaszewski moved to open the Public Hearing for discussion on the 2023 Budget. Time: 5:26pm. Discussion on library budget being over \$7400, transportation aid decreased, loan interest was down for next year and garbage & recycling and health insurance increased. - DPW and Water/Sewer Updates: DPW: down to 1 sweeper, going to put the old sweeper and lift up for sale on the auction site. Snowmobile signs will go up November 2nd. Water/Sewer: None
- 7. Discussion / Action Duroy Boat Landing. Williams updated the council on the boat landing process at Duroy. They have the permits for it, the County conservation has been helping out with the application and we could look at doing the project next fall or mid-summer.
- 8. Discussion / Action DPW Bucket Truck. Williams informed the council that our lift is not working properly, it's very slow and the lift company does not believe there is anything more than can do to increase the speed. Price Electric is selling a bucket truck for \$16,000; however, they need an answer by Wednesday the 2nd. Fixing the current lift could cost up the \$10,000 and it still wouldn't work as we would like it to. We could use the money from selling the old lift and sweeper to cover the cost of the bucket truck.

Clark/ Stephan moved to approve the purchase of the Price Electric Bucket truck in the amount of \$16,000. Roll Call: Clark -aye, Heitkemper -absent, Tomaszewski – aye, Stephan – aye, Elliott – aye, Klimowski – aye. Motion Carried

9. Wastewater Treatment Plant Upgrade Update: Wrapping up a few little things, should have a pay request next month.

Fire Department updates: Fixed the fire/storm siren by the fire hall and fixed the valve for the one truck and the get the backup engine fixed for the pump it will cost approximately \$15,000-\$20,000. Should they fix the back up engine? If the main engine goes down then we would be out a pumper. New trucks are out almost 3 years. The 15-20k could come out of their equipment replacement fund. Corner Connection did do a meat raffle for them and they raised \$2,000, fire department is putting this in savings to go towards a side by side in the future.
