Chamber: Elliott updated that the County is looking at giving all the funding for the chambers to Phillips since Park Falls chamber is basically nonexistent. New chamber director Laura Palzkill is doing a really great job. Memberships are coming in. 4th of July went very well, would like to thank the City and all others involved. Fall fest is September 25<sup>th</sup> and they will be moving it to Avon St this year and expanding it with some new events. November 8th will be the annual dinner, just not sure of location right now.
