Ludwig requested that the survey results that Price County United Limited put out regarding the EPA Community Change Grant be included as an appendix to the plan. Ludwig provided a signed document with 25 signatures supporting the request for the Phillips & Price County Engagement Survey to be included in the 2024 City of Phillips Comprehensive Plan. The Mayor did mention that some of those survey results are repeated from the community survey that the Planning Commission put out. Mark Distin spoke regarding the diversity of people and ideas observed while attending these walks and talk meetings held by Price County United Limited. He emphasized that we have an opportunity to make some changes and utilize some of the assets in our community. Brzeskiewicz discussed that these walks have sparked interest from people that may derive some business ventures. Klimowski and Brzeskiewicz agreed that the survey results presented would be appropriate to add to the appendix of the Comprehensive Plan. Ludwig did also present a map being requested to be added, but the Council felt there was no need to add it as an appendix, plus it was a smaller image in the survey results appendix that they are adding.
